The holiday book sale will be held Saturday, November 16 and in person sales Friday, December 6 and Saturday, December 7.

ACM Hall provided updates on the hiring process for the Library Director and shared location updates. The Durham Neighborhood College 2024 graduation is being held tonight. ACM Hall is attending and is a featured speaker.
